No questions were raised regarding the financial statements.</p> <p>The WHA accountant, Bill Matley, from Crispin &amp; Jeffery was present at the AGM to provide a summary of the 2020 Financials. Bill reported that the financial position of WHA is strong, and there are no concerns regarding ongoing solvency.</p> <p>At 30<sup>th</sup> June, 2020, WHA had cash and receivables of \$1.83 million. With current and non-current liabilities, there is a retained net surplus of \$499K. This is an increase from \$458K in financial year 2018-19.
